Ms. Theresa Gilbertson:

I am in receipt of your closure letter dated 9.9.22 and I have attached a response.

Cynthia Zimmer for Kern County District Attorney exceeded the maximum expenditure limits of the Kern County Campaign Reform Ordinance (KCCRO) aka Measure K and then her political campaign manager, Western Pacific Research (WPR) coordinated various "independent expenditures" on her benefit to further exceed the limits.

Cynthia Zimmer, et al violated the CA Political Reform Act under sections 81804 Perjury; 84302 Contributions by Intermediary; 84303 Expenditure by Agent, Coordinated IE Committee; 85500 Independent Expenditure Coordination; and 85701 Laundered Contributions

It is prima fascia evidence that there was coordination if a fraudulent Form 462 is filed or no Form 462 is filed. Two of the "Committees" filed fraudulent Form 462s and the other four did not file as "independent committees". Your letter only mentions one "independent committee", the others also were blatantly coordinated.

<u>Presumption of Coordination via Agent, Common Consultants ...</u> by Cynthia Zimmer, et al of six "independent committees".

Please explain how Matthew Martin is the Chief of Staff of Western Pacific Research (WPR) the campaign manager for Zimmer and at the same time is the executive officer of the Central Valley Young Republican PAC (CVYR PAC) doing an "independent expenditure" for Zimmer and he did not "coordinate" and commit perjury in signing the 462 Form.

We are baffled that the California Political Reform Act can be violated with impunity.

Dear all:

The Enforcement Division of the Fair Political Practices Commission enforces the provisions of the Political Reform Act (the "Act"). The Enforcement Division received sworn complaints alleging coordination between the committee, Zimmer for Kern County District Attorney 2018, and several committees that ran independent expenditure ads in support of Zimmer, including the People's Advocate PAC, Central Valley Young Republicans PAC, Kern County Republican Central Committee, and Kern County Young Republicans Voting Guide.

The Act defines independent expenditures to mean, "expenditures made by any person ... in connection with a communication which expressly advocates the election or defeat of a clearly identified candidate ... which is not made to or at the behest of the affected candidate or committee." Regulation 18225.7 defines the term, "made at the best of," to mean, "made under the control or at the direction of, in cooperation, consultation, coordination, or concert with, at the request or suggestion of, or with the express, prior consent of the candidate or committee."

¹ The Political Reform Act is contained in Government Code §§ 81000 through 91014, and all statutory references are to this code. The regulations of the Fair Political Practices Commission are contained in §§ 18110 through 18997 of Title 2 of the California Code of Regulations, and all regulatory references are to this source.

In this matter, the complainants alleged that the committee, Zimmer for Kern County District Attorney 2018, had a motive to coordinate advertisement expenditures with other committees because the Zimmer committee had already nearly spent the maximum allowed under Kern County law. In the last 16 days prior to the election, several committees, including the People's Advocate PAC, ran advertisements supporting Zimmer. The advertisements were reported as independent expenditures. After an investigation, the Enforcement Division found insufficient evidence to find that a violation has occurred.

Based on the foregoing, we have closed our investigation against the Respondents in this matter.

I am in receipt of your closure letter and I am baffled at the conclusion.

Cynthia Zimmer for Kern County District Attorney exceeded the maximum expenditure limits of the Kern County Campaign Reform Ordinance (KCCRO) aka Measure K and then her political campaign manager, Western Pacific Research (WPR) coordinated various "independent expenditures" on her benefit.

Cynthia Zimmer, et al have violated **CA Political Reform Act (CPRA)** under sections **81804** Perjury; **84302** Contributions by Intermediary; **84303** Expenditure by Agent, Coordinated IE Committee; **85500** Independent Expenditure Coordination; and **85701** Laundered Contributions

It is prima fascia evidence that there was coordination if a fraudulent Form 462 is filed or no Form 462 is filed. Two of the "Committees" filed fraudulent Form 462s and the other five did not file as "independent committees".

<u>Presumption of Coordination via Agent, Common Consultants......</u> by Cynthia Zimmer, et al of the following "Committees":

1) People's Advocate PAC (PA PAC) recipient committee #1404970

A Form 462 was fraudulently filed by Edward "Ted" Costa under penalty of perjury on 5/29/18.

Edward "Ted" Costa, the CEO of the PA PAC signed a media form as "People's Advocate PAC/WPR". Also, Nathan Banks, Jr., the Executive Assistant to the Chief of Staff at WPR, states on a media form that he is the "media and marketing director" of People's Advocate PAC and as "Nathan Banks of People's Advocate".

Nathan Banks is an employee of WPR. This is coordination.

2) Central Valley Young Republicans PAC (CVYR PAC) recipient committee #801804

A Form 462 was fraudulently filed by Matthew G. Martin under penalty of perjury on 6/3/18.

Matthew Martin is the Chief of Staff at WPR and is an officer of CVYR PAC. This is coordination.

The CVYR PAC did not file pre-election statements, nor reports for 1/1/18 to 4/21/18 and 4/22/18 to 5/19/18. They spent in excess of \$30,000, but there is no report of where the money came from.

No Form 462 was filed under penalty of perjury for the following committees:

- 3) Kern County Young Republicans PAC (KCYR PAC) non-existent slate mailer organization
- 4) Young Republicans for Zimmer PAC non-existent
- 5) <u>Kern County Young Republicans Voting Guide</u> (KCYR Voting Guide) slate mailer organization #590013
- 6) Kern County Young Republicans (KCYR) non-existent committee
- 7) <u>Kern County Republican Central Committee</u> (KCRCC) recipient committee #770873

- Unidentified Advertisement or Mailer; Direct mail and slate mailers mis-identified
- Contribution Limits Violation; Transfer between Candidate Committees (85306) Multiple committees used to circumvent local ordinance aggregate campaign expenditure limit, individual and committee campaign contribution limits.
- Laundered Campaign Contributions; Contributions by Intermediary or Agent (84302) Contributions funneled via fraudulent IE Committees to violate Measure K.
- Campaign Reporting Inaccurate/Incomplete; 84303 Expenditure by Agent or Independent Contractor. Coordinated "IE Committees"
- Campaign Statements Not Filed; Independent Expenditure Committee and Major Donor Committee Campaign Statement (84200) Non existent "committees"; etc.
- Violation of Rules Regarding Contributions; Violations of Voluntary Expenditure Limits (85403) Exceeding limits of Measure K.
- Advertisement Disclaimers effective 2018; "Not Authorized by the Candidate" Disclaimer for Independent Expenditure Ads (84506.5) Chad Louie for Judge mail piece

- Slate Mailer Organizations Violations; Slate mailer ID used for a single candidate; mis-identified, etc

The letter from the FPPC names Ken Mettler as the complainant.

The complaint was filed against Zimmer along with Zack Scrivner; Bryan Williams; Zimmer of Kern County District Attorney; Cathy Abernathy; Western Pacific Research; Matthew Martin; Nathan Banks; Halle Cornejo; Thomas Montgomery; Edward "Ted" Costa; People's Advocate PAC; Central Valley Young Republicans PAC; Kern County Young Republicans PAC; Young Republicans for Zimmer PAC.

23ABC reached out to Zimmer seeking comment, but has not heard back.
