

1 Amend 2 Cal. Code Regs., Section 18405 to read:

2 **§ 18405. Candidates with Multiple Controlled Committees.**

3 (a) Multiple Controlled Committees. ~~(1)~~ If a candidate or elected officer controls more  
4 than one committee for the purpose of election to office, including committees established for  
5 different terms of the same elective office or for a different elective office, the candidate or  
6 elected officer shall, in addition to any other requirements related to the filing of campaign  
7 statements, file campaign statements for each of these committees on the dates the candidate or  
8 elected officer is required to file preelection statements under Sections 84200.5, ~~84200.7~~ and  
9 84200.8 in connection with his or her election to office. Further, a candidate or elected officer  
10 shall, in addition to any other requirements related to the filing of campaign statements, file  
11 campaign statements for any other committee he or she controls, including an officeholder  
12 account committee, a legal defense fund committee, or a ballot measure committee, on the dates  
13 the candidate or elected officer is required to file preelection statements under Sections 84200.5,  
14 ~~84200.7~~ and 84200.8 in connection with his or her election to office.

15 ~~(2) If a candidate or elected officer is required to file a supplemental preelection or~~  
16 ~~independent expenditure report under Sections 84202.5 or 84203.5, only the committee(s) that~~  
17 ~~made the contributions or independent expenditures in connection with the election are required~~  
18 ~~to file the supplemental report; another committee controlled by the candidate or elected officer~~  
19 ~~which made no contributions or independent expenditures in connection with the election is not~~  
20 ~~required to file a supplemental preelection or independent expenditure report.~~

21 (b) Seeking Office in Another Jurisdiction.

22 (1) When an individual is simultaneously a candidate for elective state office and elective  
23 office in a local government agency, or for elective office in two different local jurisdictions, he

1 or she shall, in addition to any other requirements relating to the filing of campaign statements,  
2 file campaign statements for all committees he or she controls with both jurisdictions at the  
3 locations specified in Section 84215 on the dates the candidate is required to file semiannual  
4 statements under Section 84200 and preelection statements under Sections 84200.5, ~~84200.7~~ and  
5 84200.8. The candidate or elected officer shall file the originally signed campaign statement with  
6 the relevant jurisdiction (e.g., state committee campaign statement with Secretary of State, city  
7 committee campaign statement with local filing officer) and shall file a copy of the campaign  
8 statement with the other location(s).

9 (2) The cross-filing requirements in paragraph (b)(1) applicable to a candidate or elected  
10 officer seeking office in another jurisdiction do not apply to late contribution reports under  
11 Section 84203, late independent expenditure reports under Section 84204, election cycle and  
12 \$5,000 reports under Section 85309, or ballot measure contribution and expenditure reports  
13 under Section 84204.5.
