Subject: Compensation Approval for Commissioner Compensation

Date: July 8, 2019

Under the Compensation and Reimbursement Policy for members of the Commission, any claim for compensation for preparing for meetings or hearings of the Commission which exceeds forty hours of preparation (not including Commission meeting day or Committee meeting days) in a calendar month must be approved by the Commission during a regularly-scheduled Commission meeting.

Commissioner Hatch has requested for February 2019, March 2019, and June 2019 compensation that exceeded 40 hours of time spent for preparing for meetings or performing essential functions of the Commission. The timesheet is attached. In the February 2019 request, 28 hours were spent preparing for meetings and 28 hours were spent performing essential functions. In the March 2019 request, 48 hours were spent preparing for meetings. In the June 2019 request, 20 hours were spent preparing for meetings and 23 hours were spent performing essential functions.

Should the Commission approve the requested compensation, staff will process the requests accordingly.
