

1 Amend 2 Cal. Code Regs., Section 18754 to read:

2 **§ 18754. Statements of Economic Interests (Members of Newly Created Boards or**
3 **Commissions); When and Where to File.**

4 (a) Board or Commission of Newly Created Agency:

5 (1) Pursuant to Section 87302.6, an individual who is a member of a governing board or
6 commission of a newly created agency shall disclose economic interests pursuant to Sections
7 87202 through 87210. This requirement applies until such time as the member's position is
8 included in an approved conflict of interest code in effect for the governing board or
9 commission.

10 (2) A member of a governing board or commission of a newly created agency is not
11 subject to this regulation if any of the following applies:

12 (A) The member also holds a position specified in Section 87200 and the geographical
13 jurisdiction of the newly created agency is the same as or is wholly included within the
14 jurisdiction in which the member must report economic interests pursuant to Sections 87200 et
15 seq.

16 (B) The member is also designated in a conflict of interest code for another agency and
17 all of the following apply:

18 (i) The geographical jurisdiction of the newly created agency is the same as or is wholly
19 included within the jurisdiction of the other agency.

20 (ii) The disclosure assigned to the member in the code of the other agency is the same as
21 that required under Section 87200 et seq.

22 (iii) The filing officer is the same for both agencies.

1 (C) The newly created agency was formed as a result of the merger of two or more
2 agencies and all of the following apply:

3 (i) The member served on the governing board or commission of an agency abolished in
4 the merger in substantially the same capacity as the member will serve on the governing board or
5 commission of the newly created agency.

6 (ii) The geographical jurisdiction of the newly created agency is the same as the
7 jurisdiction of the abolished agency.

8 (iii) The member was previously subject to the same disclosure as required for persons
9 listed in Section 87200.

10 (D) The board or commission does not “possess decisionmaking authority” as defined in
11 Regulation 18700(c)(2)(A).

12 (3) When to file:

13 (A) Assuming Office Statement of Economic Interests:

14 (i) Every member of a governing board or commission of a newly created agency shall
15 file an assuming office statement within 30 days of assuming office pursuant to Section 87202.

16 (ii) Notwithstanding subdivision (a)(3)(A)(i), a member of a governing board or
17 commission of a newly created agency shall file an assuming office statement not more than 10
18 days after being nominated or appointed to that board or commission as required by Section
19 87202(a) if the member's nomination or appointment is subject to confirmation by the
20 Commission on Judicial Appointments or the State Senate.

21 (B) Annual Statement of Economic Interests:

22 (i) Every member of a governing board or commission of a newly created agency shall,
23 no later than April 1 of each year, file an annual statement.

1 (ii) Every person who assumes office as a member of a governing board or commission
2 of a newly created agency between October 1 and December 31 and files an assuming office
3 statement pursuant to this regulation need not file an annual statement until one year later than
4 the date applicable under subdivision (a)(3)(B)(i).

5 (C) Leaving Office Statement of Economic Interests:

6 Every person who ceases to be a member of a governing board or commission of a newly
7 created agency shall file a leaving office statement within 30 days after leaving office pursuant to
8 Section 87204 or Section 87302, as applicable.

9 (4) Where to file: Pursuant to Section ~~87500(e)~~ 87500(a)(2)(D)-(E) and Regulation
10 18730(b)(4), members of governing boards or commissions of newly created agencies, for whom
11 the Fair Political Practices Commission is the filing officer, shall file the statements required under
12 this regulation with ~~their newly created agency or with the agency's code reviewing body~~, as
13 ~~provided by that code reviewing body~~ the Fair Political Practices Commission using the
14 Commission's electronic filing system. If the Fair Political Practices Commission is not the filing
15 officer of the board or commission of a newly created agency, members shall file the statements
16 required under this section with their newly created agency or with the agency's code reviewing
17 body, as provided by that code reviewing body pursuant to Regulation 18730(b)(4).

18 (5) Effect Upon Initial Statement Required Under Section 87302(b): An assuming office
19 statement or annual statement filed under this section by a member of a governing board or
20 commission of a newly created agency is deemed to satisfy the requirement of Section 87302(b)
21 that an initial statement be filed by that member within 30 days after the effective date of the new
22 conflict of interest code applicable to that member.

1 (b) Newly Created Board or Commission of Existing Agency. An individual who is a
2 member of a newly created governing board or commission of an existing agency shall file
3 statements of economic interests as specified under subdivision (a), as though the individual is a
4 member of a governing board or commission of a newly created agency, except that the
5 individual's assuming office statement shall be filed pursuant to Section 87302(b).
