GENERAL ITEMS 22 through 26

Re-Hearing:

22. In the Matter of Frank Molina and Strategic Solutions Advisors; FPPC No. 09/807. Total Proposed Penalty: \$30,000.

Gary Winuk, Chief of Enforcement gave a brief overview of the matter. Lance Olson, counsel for Mr. Molina asked the Commission to approve the original stipulation of \$14,000 which was previously rejected.

Commissioner Montgomery made a motion to approve the penalty of \$30,000. The motion was seconded by Commissioner Rotunda.

The motion passed 5 to 0.

23. In re Costanzo Opinion Request (Our File No. O-11-178). Staff: Assistant General Counsel John W. Wallace. The Commission considered whether to issue an opinion addressing whether two members of the Selma City Council voted in past decisions in which they had conflicts of interest. Since the matter concerned a past vote, and conflict-of-interest issues are covered in Commission regulations and advice letters that could have been consulted at that time, the General Counsel, as Acting Executive Director, denied the request.

John Wallace, Assistant General Counsel gave a brief summary of the matter.

Commissioner Montgomery made a motion to deny the request. The motion was seconded by Commissioner Garrett.

The motion passed 5 to 0.

24. Amendment of Regulations 18360, 18361 and 18361.4 and Adoption of Regulations 18361.11 and 18316.6. Staff: Enforcement Division Chief Gary Winuk and Commission Counsel Sukhi K. Brar. This proposal included amendments to Regulations 18360, 18361, 18361.4 and adoption of Regulations 18361.11, 18316.6, all related to Enforcement procedures. The areas of improvement included: (1) codification of the current practice of allowing potential respondents the ability to communicate with the FPPC before a determination to investigate an enforcement matter is made, (2) codification of the current practice of assigning the General Counsel or an attorney in the Legal Division to hear probable cause proceedings, (3) amendments allowing discovery in probable cause proceedings for respondents, (4) a new regulation implementing procedures for default decisions, and (5) a new regulation focusing on treasurer liability for committee violations that would allow the Enforcement Division the discretion to hold the party who violated the Act in limited circumstances solely accountable, focusing mainly on major donor committees.

Suhki Brar, Commission Counsel and Gary Winuk, Chief of Enforcement gave a brief overview of the proposed changes to the regulations.

Commissioner Rotunda made a motion to amend the language in §18316.6 to read, "where a secretary or treasurer performs any duty." The motion was seconded by Commissioner Garrett.

Ayes: Commissioners Rotunda, Garrett, Montgomery, Eskovitz, and Chair Ravel.

The motion passed 5 to 0.

Commissioner Garrett made a motion to approve the adoption of the regulations. The motion was seconded by Commissioner Rotunda.

The motion passed 5 to 0.

25. Adoption of Amendments to Regulations, 18940 through 18950.4. Staff: Commission Counsel William J. Lenkeit and General Counsel Zackery P. Morazzini. Staff proposed revisions and updates to the gift regulations for overall consistency and clarity, and to make substantive changes to take into account the "personal benefit" language in the definition of gift, along with codifying exceptions previously provided in Commission opinions and staff advice letters for "acts of neighborliness," and "bona-fide dating relationship." New exceptions for "acts of human compassion" and "long term friendships" were also proposed. Additional changes were proposed to the home hospitality exception and modification of the valuation rule for tickets to non-profit and political fundraising events. Finally, the travel rules were consolidated and simplified.

Sr. Commissioner Counsel, Bill Lenkeit gave an overview of all the groups and individuals who helped in making the changes to the gift regulations. The decision was made to pull the personal benefit definition, closely related gifts to agency, and travel regulations for separate consideration early next year.

Commissioner Garrett made a motion to amend the language in 18940, guide to gift regulations, page 3, line 5 to read "the forgiveness of a debt or obligation." The motion was seconded by Commissioner Montgomery.

The motion passed 5 to 0.

Commissioner Garrett made a motion to amend the language in 18941, line 5 to read "official, the officials agent, or the officials family member pursuant to." The motion was seconded by Commissioner Rotunda.
