

# (Approved October XX, 2025) CALIFORNIA FAIR POLITICAL PRACTICES COMMISSION MINUTES OF HEARING, Public Session Thursday, September 18, 2025 10:00 a.m.

#### Call to Order.

Chair Silver called the meeting to order at 10:01 a.m.

1. Public Comments for items not on the agenda.

No public comments.

2. Approval of August 2025 Commission Meeting Minutes.

**MOTION:** To approve the August 2025 Meeting Minutes. Moved by Commissioner Wilson, seconded by Commissioner Ortiz. The motion passed 5-0.

- 3. In the Matter of Dougles Treisman and Treisman for Judge 2020; FPPC No. 22/714.
- 4. In the Matter of City of Hanford; FPPC No. 22/564.

Chief of Enforcement Kendall L.D. Bonebrake flagged a typographical error in the stipulation on page 13 regarding a comparable case "In the Matter of City of Garden Grove and Scott Stiles" noting a cost of \$11,526. The correct cost is \$1,526. Commissioner Brandt stated he is focused on the facts and the style, timing, and tenor when it comes to these types of cases. Commissioner Wilson stated it would be a different case if there was a balanced analysis of facts on both sides as opposed to it being one-sided advocating yes or no. Chair Silver stated there are clear regulations to consider, but it is a difficult and complex analysis. To assist in conducting this analysis, the FPPC now posts copies of the government communications at issue in advice letters and enforcement matters. Chair Silver recommended for any public attorneys advising on this topic to reach out to the FPPC for advice on what is permissible under the law.

Manager of Email Advice and Conflict of Interest Code Lindsay Rice presented the item.

**MOTION:** To adopt the amendments to Regulation 18351. Moved by Chair Silver, seconded by Commissioner Ortiz. The motion passed 5-0.

9. The FPPC Streamline Program: How It Works (Part 1).

Senior Commission Counsel Theresa Gilbertson and Commission Counsel Jonathan Rivera presented the item. Ms. Gilbertson clarified for Commissioner Ortiz that the FPPC has individuals submit complaints through the complaint portal on the FPPC website in writing. Chair Silver stated the public can view statistics on complaints and referrals in the monthly Enforcement Division's Executive Staff Report.

### 10. Legislative Update.

Senior FPPC Legislative Counsel Lindsey Nakano presented the item. Ms. Nakano confirmed for Commissioner Zettel that AB 953 excludes DACA recipients from the prohibition and they would be allowed to make contributions related to ballot measures, but not be able to vote. In regards to SB 45, Commissioner Zettel stated her concern with public financing with California already being billions of dollars in debt. She stated that it will ultimately take volunteers to get the vote out and just some money to print campaign mailers.
